CANADIAN NATIONAL TEAM TRIALS - 1983

While many of the preliminary games have already been played, you will have another chance at the Fraser Valley Club on February 3 & 10. There is still a possibility that the Kensington Club will hold a game in February. Please call George Radies (273-3003) if you are interested, as your response will determine whether a game is held. Your participation helps support the CBF, and a good turnout strengthens B.C.'s position within it. Help Canada retain a strong voice in international competition. Win red points with every match. Remember that you can play as often as you like until you qualify, but time is running out.

GRAND NATIONAL PAIRS

Sixty-six pairs turned out for the Unit Final of the GNP, approximately one-third of those eligible. While several highly-seeded pairs failed to qualify, the biggest surprise was that four of the top six finishers, including the top three, sat in the same section, same direction. In Memorium

The Vancouver Unit is saddened by the recent deaths of Mrs. Huguette Roy of Vancouver, and Jim Sessford and George Klutz, both of White Rock. Our ecndolences to their loved ones.

As a bridge player, this month's IYB editor is thoughtful, controlled, precise and articlate. Which makes why he plays with me another question entirely. He has had many tournaments successes, the most recent a victory in the Swiss Teams at the last Vancouver Sectional. On behalf of our readers, The Matchpointer thanks John for his efforts, and refrains from comment on the coincidence of the winner being on his IMP team. (Ed.)

'Fools rush in' was the prevailing view on this hand. Passes from:

Martin O'Reilly: "If I bid it's unlikely that when we hold the majority of strength partner will let us play at a makeable level.

Also, if partner holds very little I may go for 300 against a part-score."

Dave Waterman: "Partner presumably does not have a five-card major (or chunky 4-bagger). If he does, his hand is so bad they can outbid us anyway. So, give nothing away."

Ultra-pessimistic was:

Lauren Miller: " Pass. Everyone else has another bid, don't they?"

Somewhat more hopeful:

Aidan Ballantyne: "...perhaps partner will balance."

Yes, when opener is minimum with long diamonds, partner, with diamond shortness and values, will indeed reopen. Pass is also right when opener is big and flat and capable of saying Double and Redouble. The problem arises when opener is small and flat and partner has a balanced 9-11 count. He may well sell out for +50 or even -110. Blithely protecting partner from this fate were:

Leo Steil: "Double. Don't see any problem, especially being not vul. I've got support for all unbid suits."

Duncan Smith: "Double. A reasonable alternative would be to bid four clubs followed by a double of four diamonds, but the opponents won't always bid 4D."

Believe me, in this field we don't need to double if they do.

Finally, the other choice, from the counter-culture:

Joel Martineau: "Four clubs. Since pard didn't overcall one of a major, I'll hope I'm not preempting a 5-3 major fit."

That would seem to be about the smallest worry on this hand. At least 4C won't lead to a doomed Moysian, and is less likely to expose a fragile trump holding in partner's hand.

The quality of the opposition should probably enter into the question in real life, but since this is a bidding contest, the opponents are deemed to be strong and the scores are deemed to be:

How the contestants acted on this problem depended on what they expected from partner's unusual notrump. Some expected a lot:

Miller: "Six diamonds - my first inclination was to bid five hearts to direct the lead if we defend."

IYB (cont'd) page 9

Martineau: "Six clubs - just on the principal that the weaker suit should be trumps..."

Michael Dimich: "Five spades. If partner has ten or eleven cards in the minors with AK in both the grand is odds on to fall in."

Perhaps, but I'd sooner expect partner to have neither ace on this auction than both. Unusual takeouts are generally made by hands with quality suits and a shortage of defensive tricks. True, this could mean that six of a minor is a good save over five spades (and against some nervous nellies might elicit six spades), but they haven't bid five spades yet. When they do, I would expect our last plus to be defensive the vast majority of the time.

Of those who were prepared to defend five spades, some anticipated a lead problem:

Waterman: "Five diamonds. If they bid more I do not want a club lead."
Ballantyne: "Five diamonds - prefer a diamond lead."

I, too, would prefer a diamond lead, if I knew partner had the king. If partner is void in hearts, though, an underlead of the AJ could prove catastrophic. Why not let partner lead his best honour combination? Should he hold the lead you can designate a heart shift by playing the appropriate queen or jack. Thus, if you bid:

Steil: "Four notrump. No need for me to guess which minor partner is longest(sic) in."

'nuff said.

Major suit fits were on the minds of the majority. There were those who wished to play in one:

Smith: "One heart, trying to find a major suit fit. If unsuccessful will compete in diamonds."

McIlwain: "One heart - not ready to surrender the majors."

And those who wanted the opponents to play in one:

Ballantyne: "Three diamonds. Will double three of a major to show trump trick and ace of diamonds."

Dimich: "Three diamonds - maximize the pressure. You have the best of both worlds, great offense and great defense."

From the trap door spider school:

Waterman: "Three diamonds - will this work better than two diamonds? Yes, against wary opponents."

And, cognizant of his third opponent:

Miller: "Three diamonds. Could work badly if partner assumes I have no defense and saves over four of a major."

The fourth suit was not entirely forgotten:

Steil: "Two diamonds. May be difficult for them to come in with clubs vulnerable at the three level."

Well, three dimds would just about obliterate any club competition, but that bid has its disadvantages, as does one heart.

The latter has little preemptive value if the opponents own the hand in clubs, but will cetainly preempt any heart contract they may have been inclined to reach. As well, partner is entitled to expect better hearts. We really don't want him to lead one or raise with three small.

The former, while exerting pressure on the opposition, does the same on partner. Any stray major suit queens will likely be devalued, and, as the dust settles, the axe may be swinging the wrong way.

IYB (cont'd)

Two diamonds, on the other hand, still gives the enemy plenty of rope, defuses partner, allows us to occasionally reach spades (when they bid hearts at the two level), and is about the value of the hand, besides.

AWARDS: 2D = 100 (3 votes), 3D = 80 (6 votes), 1H = 60 (3 votes), 1S = 40 (1 vote), 4D = -10 (1 vote)

Most contestants decided to take charge of the hand at this point. Some felt they had as much information as they needed:

Dimich: "Seven hearts. Partner has reversed and then shown 6 hearts and five spades; with only a minimum opening he would have opened spades and rebid hearts."

or as much as they were going to get:

Waterman: "Six hearts. I defy anyone to produce a sequence enabling us to bid seven with any degree of assurance. We simply haven't enough room."

Several decided to allow partner a last chance:

Ballantyne: "4NT, 5NT. Basically going to six hearts but giving pard a chance to bid seven. Too bad we can't agree on hearts at the four level and follow with key-card."

This approach is certainly more flexible than either of the first two. I suspect Michael might be a bit shocked at the sort of hand an anonymous expert could give him to play seven hearts with. At the same time, a grand is by no means out of the question. If partner has AKQxx, KQxxxx, x, x, prospects look good and we should get there playing whatever variety we please.

Further explorations were recommended by:

O'Reilly: "Four diamonds - what I would really like partner to do is bid four hearts. If he does, I will bid RKC. If he bids anything else, I'll bid six hearts. My 4D bid will help partner assess any minor suit face cards.

Miller: " Four Clubs - would like to give partner every opportunity to show the diamond queen - will take charge later.

The trouble is, if partner bids anything more than 4H, we may as well forget about taking charge and start hoping we land on our feet.

Duncan Smith: "Four hearts. If partner is good enough to make 6 or 7 hearts on a probable trump lead he will bid again."

If he doesn't we can always pray for bad splits. It does make sonse for partner to be key-carding as we have most of the controls and he, presumably, most of the tricks. Bidding hearts at the four level is the only way to bring that about.

A problem with only two options would serve nicely as a tiebreaker to finish off the set. Although one pair, either through an understanding partnership or vice-versa, didn't interpret partner's pass as forcing, everyone else resigned themselves to acting at the five level on not very much.

Those who thought they had gone far enough:

Miller: "Double. My pass over four hearts showed about as much encouragement as my hand warrants."

O'Reilly: "Double. With my limited hand if partner can't bid five spades neither can I."

Going minus at the five level won't win too many matchpoint events, it's true, but there seems to be some dispute as to the ownership of the hand. The second round of clubs probably won't be a producer, rendering our hand just about trickless on defense. As a matter of fact, their auction is more believable than ours. If we can't make our contract, our distributional opponents should be able to make theirs.

Duncan Smith: "Five spades - and send it back real fast if they double."

And three kibitzers died laughing when they pulled to six diamonds, making.

Recently a woman at the club exclaimed, "There are no more gentlemen!" Indeed there are complaints that the standard of ethics and deportment has been sinking steadily. But nostalgia is the fad of the day and the idea that the good old days were any better may simply be the product of wishful thinking. On the other hand there is a frightening contemporary ideology that winning is everything and how you play the game is of secondary importance. It follows that there is some justification in the belief that behaviour has deteriorated and that players are sometimes guided in their actions by what they can get away with at the table or before committee, rather than by some inner sense of responsibility.

This article (in three parts) will attempt to remind Unit 430 players (myself included!) of how the game is supposed to be played. It is written for those who don't know better, and also for those who should know better.

The proper way of communicating

Section A of The Proprieties defines, in part, the correct mode of communication between partners:

Communication between partners during the auction and the play should be effected only by means of the calls and plays themselves. . . Calls should be made in a uniform tone without special emphasis or inflection, and without undue haste or hesitation (however sponsoring oganizations may require a mandatory pause following a skip bid). . . Plays should be made without emphasis, gesture or mannerism, and so far as possible, at a uniform rate.

Some common violations:

- The 'co-op double' delivered in a hesitant, somewhat interrogative tone of voice.
- The obvious penalty double boomed out instananeously in a tone of complete finality.
- 3. The 'Blackwood sign-off' when, after a rather confused auction, 4NT is bid after an inordinately long pause and much scratching of the head. The intent of the bid is sometimes made clear by placing one's cards face down on the table, crossing one's arms and leaning back in one's chair.
- 4. The literally 'forward-going' minimum raise; extra values are shown by raising in an eager tone while leaning forward over the table.
- 5. The slow duck, by a defender, which usually conveys the possession of an ace.

There are many other types of infractions. They are all violations whether intentional or not.

Unauthorized information

The partner of the violator in these cases is said to have unauthorized information. Law 16(2) states:

Any information conveyed by a player, other than declarer, to his partner by means of a remark, question, unmistakeable hesitation, special emphasis, tone, gesture, movement, mannerism, or any other action that may suggest a call, lead or plan of play, is illegal, unauthorized information.

What a player does with this unauthorized information is what determines whether he/she is a gentleman/lady. Section C (Part II) of The Proprieties states:

When a player has available to him improper information from his partner's remark, question, explanation, gesture, mannerism, special emphasis, inflection, haste or hositation, he should carefully avoid taking any advantage that might accrue to his side.

The problem is how to determine if advantage is being taken, consciously or subconsciously. Since the ACBL is not currently employing hypnotists, truth serum or lie detectors, the director follows a carefully worked out procedure to remedy the situation. Overall, the director's actions are guided by the following code from The Propieties:

If the director determines that a player chose from among logical alternative actions one that could reasonably have been suggested by his partner's tempo, manner or remark, he should award an adjusted score.

Note the wording "could reasonably have been suggested" not "was suggested"! In his approach the director (and the possibly ensuing committee) must sottle four separate issues:

- 1. Was there a violation?
- 2. Could the innocent side have suffered damage thereby? (Again, note the "could".)

If the answer to these two questions is Yes, then the next two issues are considered:

- 3. Were there logical alternatives to the chosen play or call? A logical alternative is one which might be chosen by a substantial proportion (one in four) of <u>equivalent players</u> acting on the basis of all the information, <u>were it logitimately available</u>.
- 4. Could the violation reasonably suggest that the call or play chosen at the table would be more successful than one of the logical alternatives?

If the answer to all four questions is Yes, then the score may be adjusted.

The most common cases involve hesitations during the bidding, so it may be instructive to consider a 'huddle muddle'. South, at unfavorable vulnerability (matchpoints), holds:

AJx 10x Qxx. KQJ9x

South opens 1C as dealer and West, after announcing a skip bid, calls 3H (preemptive). North takes a long time and finally doubles, conventionally for penalties. East passes and South bids 3NT. West calls the director who advises the players that he should have been summoned immediately following North's hesitation. Nevertheless, the director asks that the bidding and play proceed while he retains the right to adjust the score. All pass and 3NT goes down one for E-W +100.

Following the above procedure the director establishes that there has indeed been a violation. North was entitled to about ten seconds of thought after the skip bid, but the players more-or-less agree that North took close to a minute to double. The director next addresses the question of damage and decides that E-W could have been damaged as they could have made 3H by guessing the location of the diamond Q. In fact, many E-W pairs have made 3H for +140 (playing opener for the QD) and +100 is not a good score for E-W. The third question is: Was there a logical alternative to the bid of 3NT? The director decides that, faced with an in tempo penalty double, a substantial number of players (at least one in four) of South's calibre would pass the penalty double. The logic behind the two obvious choices might be:

- a) 3Nt. South has more clubs than he might, playing standard. His lack of aces might hurt the defense. The good club texture may make 3NT playable, whereas the penalty might not compensate for the vulnerable game.
- b) Pass. South has the full opening bid he promised. His hand is flat. The doubleton heart 10 may be a positive factor on defense. He can stand a club lead. He should respect partner's judgement. His partner knows the vulnerability.

The director now considers the question of whother or not the hesitation made the 3NT bid more attractive than the Pass. In his judgement the director ignores what he knows of South's character and pays no attention to arguments such as "I would have bid 3NT without the hesitation" or "I always try to bid vulnerable games at matchpoints." The question is, could the slow double have encouraged a player to bid 3NT rather than sit for the double?

The director decides that in the present case the answer is Yes. North's pause likely means that North is thinking of bidding 3NT himself, or that he is not trump-rich for his double and is uncertain about his defensive

prospects. Either way, this illegal information <u>could reasonably</u> have suggested the 3NT bid over the Pass. This decision does <u>not mean N-S</u> are accused of cheating. South had to do something and, hopefully, he did the best he could under the circumstances. The director now decides to set the score at 3H^X making, but advises N-S of their right to appeal.

The role of the Committee

On matters of bridge law, the director's say is final. However, the Committee may review those aspects of decision-making that require judgement. The Committee also has disciplinary powers.

Taking the above case, the Committee retraces the director's thinking and reviews his judgement. Thus, the Committee may decide that there was no infraction (say the hesitation itself is in dispute); may overturn the director's decision that E-W could have been damaged (in which case the result of E-W +100 would stand); could decide that more than 75% of South players of equivalent calibre would bid 3NT and that there was no logical alternative to South's call (again, E-W score +100); might overrule the director's judgement that South's call could reasonably have been suggested by the huddle (once more, E-W score +100). Finally, the Committee may have some doubts and decide that E-W should receive an average plus on the board rather than the top they would get for +530. N-S might be dealt an average minus or a zero depending on the Committee's conclusions.

If North and/or South appear frequently before Committees in similar circumstances, the Committee may decide to take disciplinary action.

The pause that refreshes

Tempo problems crop up frequently in the play, often involving the play of third hand to trick one. Declarcr, who has the advantage of seeing 26 cards, may play quickly from dummy after the opening lead. Third hand may hesitate unduly, being faced with a difficult play, or one that may be crucial to the rest of the defense. Such hesitation often yields unauthorized information about third hand holdings. For these reasons it is common courtesy in top-flight games for declarer to pause at least 30 seconds before playing dummy's card to the first trick. Perhaps this will eventually become ACBL policy (like skip bids). Meanwhile the 'first trick pause' is a worthwhile habit to develop as declarer. Declarer ends up making fewer hasty mistakes and helps all the players to develop an even tempo. This makes the game more enjoyable for all.

Intentional variations

This section would not be complete without a discussion of the problem of players intentionally hesitating with singletons and committing related infractions with the purpose of deliberately misleading opponents.

The Proprieties state:

It is grossly improper to attempt to mislead an opponent by means of remark or gesture, through the haste or hesitancy of a call or play . . . or by manner in which the call or play is made.

And:

If the director determines that an innocent opponent has drawn a false inference from deliberately and improperly deceptive information, he should be awarded an adjusted score (see Law 16).

On the other hand, it must be remembered that:

Inadvertently to vary tempo or manner in which call or play is made does not in itself constitue a violation of propriety, but inferences from such variations may properly be drawn only by an opponent, and at his own risk.

Conclusions

It is now possible to deal with the question: "Well, what do I do when partner balks revealingly or bids in a suggestive tone of voice?" Answer: You don't try to interprete partner's problem to your own advantage, thinking that you might get away with it or, at the worst, face a committee. Instead, you do your utmost to bid or play as if there hadn't been a problem. This is difficult to do. One approach is to go over the available

alternatives in your mind and select what you feel would be the majority action. Of course, this isn't a fun way to play the game. Even if you do your best, you will often find that the score is adjusted in favor of your opponents. This is because the non-offending side gets the benefit of the doubt, and is fully entitled to redress when: 1. there was a possibility of damage, 2. there were other obvious calls or plays available to you, and 3. there was a reasonable theoretical possibility that your action was influenced by partner's balk or tone of voice. So, if you find that partner's problems are causing you repeated poor scores from adjustments, and much time in the director-committee spotlight, encourage partner to bid and play more smoothly. If that fails, find a new partner!

In this case, best declarer play will beat best defense, so <u>play</u>, but be careful!

Ruff the opening lead with the 10 or 9 (essential) and play a low club from both hands. Win the minor suit return (best) in dummy, and finesse the heart 7 - or as high a heart as is needed to win the trick. Ruff a spade with the remaining high heart, finesse in trumps again, pull trumps and claim. Alternately, the heart may be finessed at trick 2 and the club ducked at trick 3.

Note particularly what happens if you ruff low at trick 1. East can sequently insert the heart 8 when you lead low from dummy, and you will be

unable to unlock communications to draw trumps.

Lest you think this is a purely theoretical problem (who in their right minds would bid such a skimpy slam?), in a recent challenge match between the CNTC teams of our illustrious editor and his humble contributor both teams staggered into 6H!

[As a matter of record, our humble contributor shellacked our il.ed. in said team game. Ed.]

A Note On Non-Standard Card Play

When using non-standard leads (e.g. Acman Reverse Signals, L vinthal Discards), you should place a note alongside your conventions card saying: "We use - Upsidedown Signals & Discards" or whatever. Your opponents have the right to know.

Some couples call it "divorce doubles", a game invented to enrich lawyers. It real name, of course, is mixed doubles, and it is that exas-

perating game of tennis in which men and women are partners.

Hundreds of so-called "social" mixed doubles games are played on
summer weekends at tennis clubs throughout the [New York] area. Many of the matches are marked by constant bickering, especially if the partners

on one side happen to be married.

This bickering has gone on as long as mixed doubles have been played. But some observers of the tennis scene believe it has become louder as the female partners, emboldened perhaps by the women's movement, no longer suffer in silence.

Celeste Cutrone, for example, tried to put an end to an unpleasant situation before it affected her marriage. Mrs. Cutrone said the squabbling with her husband, Ralph, would begin whenever she made an error, and he would ask her questions such as "What do you call that shot?" During one such quarrel Mrs. Cutrone walked off the court, saying to the other couple: "Bye, everybody. Ralph is going to play you by himself."

Nowadays, the Cutrones are playing mixed doubles together again.
Their matches are fairly peaceful, Mrs. Cutrone says, "because all I have to do is say, 'Ralph, you're asking questions again,' and he stops - he doesn't want me to walk off the court."

On most mixed-doubles teams, the man, as the stronger player, tends to dominate play on his side of the net. Many female partners find this irritating; others, especially those who are weaker players, welcome it, feeling that the less often they have to hit the ball, the better.

Brenda Feigen said tennis was the one area of her life where she did not consider herself the equal of her husband. "But I still don't think he should hog all the balls. And I get angry when he's at net and leaps into the air for a ball that I could have easily returned from the

baseline. Frankly, both of us prefer singles."

"The best thing you can do is give your partner all the support you can, short of being ridiculous," said Dr. James T. Holmes, a Manhattan psychiatrist who is an avid tennis player. "You just have to be supportive and encouraging, no matter how you feel or what the score is. It will pay off in the end.

The UNIT 430 Annual Meeting will be held on July 3 before the Unit Game, at the Haida Club, 2182 W 12 Ave, Vancouver. Meeting time: 6:30. A quorum of 50 is needed to begin the meeting, so please attend or the game time may be delayed.

The recent BC Regional was, by all standards, an unqualified success (unless you failed again to get the gold points you need). This success is almost entirely a reflection of the support shown by the members of Unit 430, as well as the other units of DINO.

A study of the entry blanks shows that about 40% of the participants were local, with another 45% being split about equally between other areas of BC and Washington. The rest mainly came from Alberta, Oregon and California, with a few from other Canadian areas and almost no-one (except some pros) from other US points.

Thus the fears expressed by many that attendance would be down due to the recession and the proximity of the Hawaii Nationals were probably correct with respect to those who travel some distance to go to Regionals, but this was more than offset by the fantastic support we received from the local players.

The final total of 2,649 tables was only a few short of the DINO record (set in Victoria in 1980), and despite the widely-held view that a Regional could not be held profitably in Vancouver owing to high rental costs, etc., we were well within budget, and in fact turned a profit more than enough to cover DINO's expenses.

I again want to thank everyone who helped make the event such a success, especially Hospitality Chairman, Marcia Kostynyk, and Partnership Chairman, Jennifer Paynter, and their tireless and efficient helpers; but most of all it was YOU, the members of Unit 430, who assured the success of the tournament.

For your information, your unit is immediately entering into negotiations with DINO to re-obtain a Vancouver Regional on a bi-annual basis.

What I did was I passed and ol' pard led a diamond, I think, and LHO managed to stop laughing long enough to take 13 tricks and I blew the next board on the rebound, but you'll never guess — we won on the hand. Our other half played and made six spades doubled, and you really don't know what might happen in the Twilight Zone.

While this was going on <u>Borg</u> beat Jacob 74-38 to become the first-place finishers. After their close escape against Bryden they never looked back.

It turns out the man who had gone minus 200 in JNT was quite definitely a "known" player. I must have been one of the very few people in that room who hadn't recognized Benito Garozzo.

The Canadian National Team Trials are upcoming, and if last year is any indication our Unit will have an extremely poor turnout at the club level. Last year B.C. had by far the worst turnout in Canada, with Vancouver leading the way (downhill). As Unit 430's co-ordinator of special events, but more importantly as a Canadian bridge player, I am concerned about this lack of participation. At this time, only one club - the Haida - is committed to holding qualifying games [see below].

In the past few weeks I have had discussions with several club managers and directors concerning the problems involved in holding a CNTC game. I particularly recognize the difficulty of staging a two-session event at a facility that holds only one game per week. But I can't help but believe that there are more interested players than our past participation suggests. Aside from offering red points for all matches won and giving us a break from the quirks of matchpoint duplicate, this event is our only national championship, a chance for all of us to have a hand in the choosing of our country's #1 team for 1984. I also feel that many players are unfamiliar with two amondments made last year to the conditions of contest. First, any team which fails to qualify in its first attempt may try again. Second, a team which has four players with a thousand masterpoints is exempted from the qualifying stage. The latter lessens the chance of a ringer team showing up at your local club and 'stealing' your position, and both give us all a better chance of qualifying.

I do appreciate that to most bridge players their weekly night of bridge is a social event, and one they do not wish to give up. However, there are some clubs which can and may hold a CNTC event on a non-game date (e.g. a two-session event on a Saturday or Sunday). Another possibility is a final qualifying game at a central location for any of us who have failed to qualify to that point, or have thought about playing but haven't gotten around to it, or just feel like spending a pleasant day playing team bridge. I feel that both these alternatives are good possibilities, but unless the clubs get active requests and support, these games will never take place. Club owners and directors are reluctant to hold these games on specu tion — they have been disappointed in the past.

Last year there were serious conflicts in dates. I need your co-operation to avoid a recurrance of this problem and to allow for time to publicize your qualifying game. If you have set a date or are considering doing so please let me know! To improve participation in these team trials, and to better people's understanding of, and attitudes toward, this event, we need your input and support. If there are any questions or comments, please feel free to contact me,

A note on the Price: The CBF charges a fee of \$20.00 per team to play in the qualifying stages (a higher rate is charged to those teams who are exempt). This is rather steep, but is based on the number of people who play in the event. If you are avoiding this event until the price goes down, please reconsider. The only way the fee can be reduced is through increased participation. Right now the few are paying for the many. We urge you all to bite the bullet, spring for the five bucks, and come out and Q. For a good time, call Marty, and play a few hands for your country.

DOING IT RIGHT:

Part II: Partnership Agreements

Partnership agreements can take the form of CONVENTIONS or TREATMENTS.

A convention is an agreement whereby a call is assigned an artificial code meaning. For example, an opening bid of 2D showing 11-15 HCP and 5 hearts and 4 spades is a convention: the call has no meaning with respect to the strain bid, diamonds. Similarly, an opening bid of 10 showing 16+ HCP is conventional, since the bid is a cypher, saying nothing about clubs. For every ACBL game, there is a list of authorized conventions.

If conventions were not regulated, a lot of time would be spent at the bridge table discussing various defences to new or unfamiliar conventions, and duplicate sessions would be severely disrupted.

Use of an unauthorized convention is considered an infraction and redress is given in case of damage.

A treatment is an agreement whereby an otherwise natural call is given some specific meaning as to strength or distribution. For example, a partnership may treat an opening bid of 2S in one of two ways (among others): as a weak hand with 6 spades, or as a strong hand with game-going values. In both cases the call relates only to the strain bid, spades, and is not artificial. All treatments are legal; partnerships can choose their preferred treatments or even invent their own.

The use of conventions and treatments by partnerships is guided by the following code, from the Laws of Duplicate Cantract Bridge:

> A player may not make a call or play based on a partnership understanding, unless an opposing pair may reasonably be expected to understand its meaning, or unless his side discloses the use of such a call or play in accordance with the regulations of the spesoring organization. (Law 40/B)

and:

It is improper to convey information to partner by means of a call or play based on special partnership agreement, whether explicit or implicit, unless such information is fully and freely available to the opponents. (Propieties, Part IV/A)

The intent of the law is clear: opposing players have the right to know everything there is to know about another partnership's agreements.

In the ACBL, partnerships must disclose their agreements in two ways.

First, they must give opponents advance notice of their agreements by listing them on their convention cards. In some cases, as when a pair is using special defensive discards, the agree ment should be disclosed verbally also, when the opponents sit down at the table.

Second, partnerships must notify the opponents of an agreement at the time a, call with special partnership meaning is made, by means of the Alert Procedure.

Standard ACBL convention cards are designed to accommodate the more common and usually-authorized agreements. The convention card format is in the form of a checklist, with descriptions of various conventions provided on the card. All conventions described in red ink are to be Alerted. Those in black ink are considered very common and should not be Alerted. Extra space is provided at the bottom of the card for description of less common conventions and treatments. Obviously, it is impossible to list and describe all the agreements a partnership may have. Thus, for those agreements not listed on the card, the Alert Procedure becomes all-important. In order to clearly establish agreements, both players of a partnership must have identically filled-out convention cards.

The Alert Procedure

ACBL regulations require a player to Alert the opponents immediately when his partner makes any call that carries a special partnership meaning. Before the start of the round, a partnership may request that it not be Alerted. Then, the opponents must not give Alerts, but the requesting partnership's responsibility to Alert their own bids remains. When a partnership requests that their opponents not Alert, they retain the right to ask questions about the opponents' methods at their turn to bid. Alerts should be given by saying, simply, "Alert!", and nothing else. It is a serious infraction to volunteer any kind of explanation along with an Alert.

The Alert Procedure has various drawbacks. First, a player may Alert when he should not. That is, he may think there is an agreement when, in fact, there is none. Second, a player may forget to Alert, either out of thoughtlessness or because he has forgotten that he and his partner have an agreement. Third, a player may Alert and give an erroneous explanation of an agreement. Fourth, a player may Alert correctly and deliver an appropriate explanation, but this may serve to remind his partner of an agreement that he has forgotten. There are carefully worked-out procedures for dealing with inappropriate Alerts and explanations, but these are beyond the scope of this discussion.

Needless to say, as imperfect as it is, the Alert Procedure is necessary to maintain ethics at the level outlined in Law 40/B and Part IV/A of the Proprieties. It is important to Alert whenever you are sure you have a partnership agreement which is not common, and whenever you think the opponents do not know your particular agreement.

What Is Alertable?

Except for those listed as Class A, such as Stayman, Blackwood and Take-out Doubles, all conventions should be Alerted. Natural calls, which are bids that do no more than suggest a final contract, need not be Alerted, except when a partnership decides not to use the three conventions listed above. In this instance, those calls must be Alerted as natural.

For treatments, there is no hard and fast rule for Alerting. Generally, no Alert is necessary for treatments that everyone uses, such as an opening 3-bid showing a long suit (6-7 cards long) and a weak hand, which are described in black on the ACBL convention cards. Other treatments, such as new suit forcing by an unpassed responder are so basic that they need not be Alerted.

However, unusual treatments, such as weak jump shifts, weak double jump raises, or passes that are forcing when they might be expected to show weakness, are all Alertable.

Obviously, a great deal of subjectivity enters into judging whether or not a treatment should be Alerted. What might be considered standard in some parts of the country may be regarded as unusual in another. What good players might perceive as obvious might be unknown to the less experienced. The bottom line is that every player is responsible for protecting his opponents according to the intent of Law 40 and the Proprieties: the opponents are entitled to know all your partnership agreements!! Thus, if you are in any doubt as to whether or not an agreed

treatment should be Alerted, you should Alert, especially if you are sure you and your partner have an understanding about the call made.

An example of a situation where experienced players may take advantage of beginning ACBL players arises with 'co-operative doubles'. Such doubles are treated by good players as showing maximum values for past bid(s) and a willingness to compete further. In the absence of an Alert, the inexperienced player believes the double to be for penalties. Thus, when the doubler's partner, holding a poor hand, removes the double, the innocent victims may sell out cheaply, fearing that further bidding by them might result in a hefty penalty. In many cases, it is only when the novices scan the hand records in search of an explanation for their virtual zero that they begin to suspect that their opponents' double was something other than for penalties. Is is a sad fact that many experienced players get away with irregularities because less experienced players can't identify them.

When a player judges not to Alert, and the opponents legitimately protest that they did not know the meaning of a treatment, redress may be given them in case of damage. In such situations, whether or not failure to Alert constitutes an infraction must be decided by the Director or subsequently by a Committee. These authorities substitute their judgement for a player's, deciding whether or not it was reasonable to assume that those particular opponents would understand the particular treatment without an Alert.

Explanation of Partnership Agreements

After an Alert, the player whose turn it is to bid may ask the appropriate opponent about the agreement. In responding to a query, a player is guided by the following code:

When explaining the significance of partner's call or play in reply to an opponent's query, a player should disclose all special information conveyed to him through partnership agreement or partnership experience; but he need not disclose inferences drawn from his general knowledge or experience. (Proprieties, Part IV/C)

For example, after the auction, 16-1D-Dbl*, where the double is negative, the 10 bidder must give a full account of the meaning of the double when responding to RHO's query. The opening bilder should tell his opponents whether the double shows 4-4 in the majors, or whether the doubler may have only one major with support for clubs, etc. Again, bullish veterans may take advantage of weaker opponents by intimidating them with a curt and insufficient explanation: "Negative! What else!" This type of behaviour is extremely unethical.

It should be noted that queries on the meanings of calls or plays are not restricted to situations in which Alerts are given:

During the auction and before the final pass, a full explanation of any call made by an opponent may be requested by any player, but only at that player's turn to call. (Law 20/F/1)

and,

After the final pass, and throughout the play period, declarer or either defender may request such an explanation of opposing calls, and declarer may request an explanation of the defenders' card play conventions, but only at his own turn to play.(Law 20/F/2)

All such queries must be answered in the form prescribed by the abovementioned code from the Proprieties(Part IV/C), An example of the above
principles may be found in a Bridge World editorial (Bridge World: May, 1979)
which considered the case of a declarer asking a defender about his partner's
style of opening leads against slams. The declarer was faced with a guess
at trick 1, having received the lead of a low spot through a suit headed
by the KJ. The editorial concluded that declarer did indeed have the
right to enquire about lead style, and that a defender had to share all
the information with him, as long as this information was based on previous discussion or partnership experience.

Violation of Partnership Agreements and Psychics

Perhaps the most controversial aspect of partnership agreement is that which results from repeated psyching. Generally, psyching is one of the most debated subjects in bridge. Psyching seems to create a great deal of tension and unpleasantness at the table; as a result, many in the ACBL advocate banning psychics. However, there are difficulties with this approach. First of all, it is difficult to precisely define psychics.

What some would consider a psychic bid, others would call a light opening cr a tactical bid. In addition, and more importantly, the ACBL must adhere to the Laws of Duplicate Bridge, which consider psychics legal. The relevant section of the Laws states:

A player may make any call or play (including an intentionally misleading call - such as a psychic bid - or a call or play that departs from commonly accepted, or previously announced, conventional practice), without prior announcement, provided that such a call or play is not based on partnership understanding.(Law 40/A)

and,

It is not improper for a player to violate an announced partner-ship agreement, so long as his partner is unaware of the violation (but habitual violations within a partnership may create implicit agreements which must be disclosed). No player has the obligation to disclose to the opponents that he has violated an announced agreement; and if the opponents are subsequently damaged, as through drawing a false inference from such violation, they are not entitled to redress. (Proprieties, Part IV/B)

The real problem with repeated psyching is that implicit partnership understandings are created, and with respect to psychs, such understandings cannot usually be disclosed to the opponents. For example, a partnership may psych major suit openings in first seat at favorable vulnerability on a regular basis. Some mention of this may even be made on the convention card. However, after such an opening bid, opener's partner has no way of being 100% sure that the opening is a psych. He therefore cannot Alert. On the other hand, he may respond in such a way as to cater to the possibility that his partner has psyched, therefore demonstrating the presence of an implicit understanding. Meanwhile the opponents must carry on the auction in relative ignorance of the actual understanding. In other words, the Alert procedure works well when bids carry specific, narrow meanings which can be described in response to an opponent's query; it doesn't work well when a particular bid may or may not carry a specific meaning.

Another problem with psychs and the Alert Procedure has been described by Don Oakie in the ACBL Bulletin in a February, 1978 article:

Since players rarely think to disclose implicit partnership understandings prior to the situation actually arising during the auction — and for all possible situations it would be practically impossible to do so — the Alert Procedure's protection is invaluable where implicit understandings are involved. Where psychic bids are concerned, however, the nature of the bid or call is such that the need to disclose implicit understandings has the effect of practically preventing their use.

Put another way, if a perfect procedure were invented to disclose psychics to the opponents with 100% accuracy, the ethics of the game would be maintained, but there wouldn't be much point in psyching!

In response to the problem the ACBL created a policy outlined in the Oakie article. One objective of that policy is to eradicate excessive psyching. Oakie says:

Even when the partnership involved has assiduously Alerted all opponents to the possibility that some or all of their calls may be psychic, the partnership may find itself in violation of the Proprieties. The League has prohibited the use of psychics on 'virtually every hand' on the grounds that such bidding disrupts the orderly progress of the game. If the director finds that the partnership agreements relative to their use of psychic calls, and the Alerting thereof, is[sic] disrupting the orderly progress of the event, he may order the partnership involved to discontinue their disruptive tactics or face expulsion from the event.

The section of the Proprietics referred to by Oakie is:

Every player should follow uniform and correct procedure in calling and playing, since any departure from correct standards may disrupt the orderly progress of the game.

In general, the Oakie article states that psyching is theoretically legal, but that it is futile to psych against good players and unsporting to psych against weaker ones. Players who have psyched together a few times develop "implicit agreements". Their technical right to psych is valid only if all their implicit understandings are disclosed through

an Alert at the time of the psychic bid — an Alert that is virtually impossible to give. And even if all Alerts are properly given, psychers may be penalized as disruptive. Some of the essence of the Bulletin article was captured in this limerick:

Thanks for the Bulletin's clever Clarification endeavour: "It's legal to psych As much as you like So long as you like to psych NEVER."

Scare tactics aside, there is another aspect of ACBL policy that is true to the spirit of the Laws and the Proprieties: it is that part of the policy that is directed not against psychics, but against concealed, implicit understandings. According to this policy, a player who makes a grand-stand catch of his partner's psychic is presumed to have acted on improper information. Unless the player can demonstrate otherwise, his score will be adjusted. Thus the policy accepts the fact that psychics cannot be properly Alerted. Since he cannot Alert, the partner of a presumed psycher must bid his hand normally, at least until he can claim to have received explicit information that his partner has psyched. If he does not bid normally, a concealed understanding is presumed to exist, and the score will be adjusted.

A case in which this policy was applied was considered in the Bridge World (June, 1978):

In this situation South bid his hand rather strangely and the onus is_ on him to explain his actions. Until he proves otherwise, South is presumed to have acted on the basis of concealed, illegal partnership agreement. If South cannot prove that there was no concealed understanding the score may be adjusted, assuming the Director or Committee judges that East-West were damaged as a result of South's infraction. If South often finds himself trying to explain his fielding of psychics, he may be disciplined. Suppose his explanation is, "With both opponents bidding, partner just couldn't have a real take-out double since I held so many points, so bridge logic prompted me to take it easy". This argument is not convincing, since if there was no concealed understanding, South might suspect West or East (look at the vulnerability!) just as much as his partner. He would be expected to bid the full value of his cards. According to BW's Edgar Kaplan, a satisfactory explanation might be, "Our agreement is that a take-out double promised 13 HCP and the opponents play 1H forcing, so on the bidding someone had to be lying. Since East-West's card says they never psych, it had to be North". If this is true then it follows that everyone should check their psychics as 'occasional' or at the very least 'rare', so that people such as South in the above hand would have trouble putting forward a suitable explanation for their strange actions. In fact, in these types of situations it is difficult to find a satisfactory explanation for apparent 'catching'. Generally, when one is a member of a frequently psyching partnership (even one that psychs as little as once every ten sessions), the ethical approach is to bid normally. Either that or stop psyching as a artnership! Every hand should be approached on the basis that the opponents are just as likely to psych as partner. "Table feel" is an inappropriate explanation of grand-stand catches. Such explanations lead to deservedly tarnished reputations.

1. IMP's. Both vul. <u>M N E S</u>

To double or bid on? Most successful players tend to take out insurance (via bidding one for the road) on these types of problems so as to avoid a large swing. While this is sound IMP strategy, many a match is won or lost on such 5-level decisions.

For the bidders:

Joel Martineau: "5D. My declarer play versus my defense (4SX). The former is rather less likely to result in disaster. I try real hard to avoid disaster at IMPs and rubber."

Peter Herold: "4NT[KCB]. If no aces may be good sac in 5H! If one ace will bid slam. If two aces will cue 5S."

David Waterman: "5H. Lose 6 IMPs at worst."

And the doublers:

Laurence Betts: "Double. We can tap RHO in hearts. Assume he has 7 spades. Yes I know partner might have 0-5-4-4 with no tricks, but then he would pull anyway."

Lauren Miller: "Double. Contrary to my usual policy of taking out insurance against double game swings, but if we can't beat this one I assume partner will pull."

Duncan Smith: "Double. Don't know if we can make 5H (doubt it), and heart taps could result in 4S going for a bundle."

From out of the [purple] haze:

Dave House: "Pass. Forcing."

The ensuing auction will be equally succinct, Dave, as partner smoothly passes.

AWARDS: 5H = 100(8 votes), Dbl = 80(6 votes), 4N = 70(2 votes), 5D = 70(2 votes), 9D = 70(2 votes), 9D = 70(2 votes)

2. Board-A-Match. Both vul. S M E AJ765 P P 15 2D AJT7 P 3D 2H P K6 J3

Do we bid on, and if so what game try do we make? The consensus was to take a sure plus.

The plus score theorists:

Steven (No Bid) Vincent: "No Bid. 3D isn't forcing where I come from and we're not making any more if partner hasn't anything extra."

Aidan Ballantyne: "Pass. Would try 3N if I need to swing."

Sandy McIlwain: "Pass. Game seems hazardous at best."

And for those with a higher rod blood corpuscle count:

Duncan Smith: "4D. Too good to pass, wrong hand to treat as a 5-card heart suit, 3N is just wrong, so what's left?"

Dave House: "3H. I don't like to lie, but I haven't got the nerve to bid 3N with team mates to account to. I'll correct 4H to 5D or pass 3N."

I agree with this approach, as partner's first priority should be to bid 3N rather than show heart support, hence the 3H bid caters to arriving at 3N when it's right but doesn't preclude a diamond contract."

And not lacking nerve or fearing team mates were:

Lucky O (Reilly): "3N."

Leo Steil: "3N. Six diamond tricks, two aces, plus a club if partner's outside honour is in clubs or a third major trick if it's there."

AWARDS: Pass = 100(10 votes), 4D = 70(5 votes), 3H = 60(3 votes), 3N = 50(2).

3. IMP's. Both vul.

I received several complaints about the 2S rebid - sorry - but doesn't the end justify the means in that we now seem well placed to arrive at 7D with partner holding as little as x Axxxxx AQxx xx. I for one fail to see how 7D would be reached after a 3S rebid.

The 4C bidders had little to say other than that they were saving space and wanted to hear more. As for the 4D bidders, some expressed concern as to how to explain why they played part score rather than grand slam to curious partners. As mentioned earlier, all we need for 7D is the heart A and the diamond AQ (I know diamonds may not split, but partner may have the knave or extra length), so what is the best method of getting partner to co-operate holding these controls? I feel 5C should do the trick - if partner bids 5D we will continue with 6C and surely he will now bid the grand holding the three necessary controls as we must have a source of tricks to try for a grand missing three key cards. Anyway, that's the way I see it.

Dave Waterman: "5C. This is clearly a void, even with no agreement, The auction has worked out well - it would never have occurred to me to bid only 2S."

Steven Vincent: "5C. Why have I been saddled with this 2S bid? This hand's huge. Bid 3S at least. Now 5C expresses the hand well."

AWARDS: 5C = 100(6 votes), 4C = 80(4 votes), 4D = 70(3 votes), 4N = 50(2 votes), 6C = 50(1 vote), 6S = 40(2 votes), 3S = 20(1 vote).

4. Matchpoints. None Vul.

Are there any used car salesmen out there? We want to bid slam with these cards but are afraid of two quick club losers. If we cue bid on our way via 4D or 4H it may well make life difficult for partner who is not looking at any high spade honour and may be hesitant to cue 5C. Hence many solvers simply blasted to 6S:

Leo Steil: "6S. Could be off two club tricks which they may not lead unless we inform them. Partner must have good cards in the minors as they are not in the majors."

While I agree 6S is a reasonable bid I feel there is room for a little larceny on this hand. If we are going to 6S regardless why not try 5C first to spike the club lead? Also, although unlikely, 4C may get doubled by LHO, which will allow partner to inform us of his club holding.

Laurence Betts: "4C. Blow off the club lead before leaping to six spades." [Presumably this bid would be alerted by any regular partnership: "Tends to deny club control when followed by leap to slam." Ed.]

[Just kidding? Ed.]

AWARDS: 4C = 100(6 Votes), 4H = 80(5 votes), 6S = 70(4 votes), 4D = 70 (4 votes), 3N(systemicly asking for controls) = <math>70(1 vote).

5. IMP's. Both vul.

The solvers covered all the bases on this one:

Leo Steil: "2NT. Solid hearts should all be tricks in NT - more likely to take 9 tricks in NT than 10 in hearts."

Lauren Miller: "2NT. Would obviously prefer a better club stopper, but neither 2H nor 3H describes this hand. This may be what partner needs to hear."

Duncan Smith: "3H. Seems about right, but will make it impossible to get to 3NT if partner holds Jx or Jxx of clubs."

Al Chapelle: "3H. Will play 4H or 3N = help."

Joel Martineau: "Pass."

I don't know what kind of mind altering agent you were using, Joel, but it was working.

AWARDS: 2N = 100(8 votes), 3H = 80(6 votes), 2H = 60(4 votes), Pass(!) = -10(1 vote)

Ganadian Pairs Championship

The recent fall Olympiad Fund game was also the first leg in the re-established CPC. While we regret having been uninformed and therefore unable to advertise this event previously, here is a brief description of age the CPC will work:

The CPC will be held twice every four years. The qualifying events for the 1935 National Finals are the just-held Olympial Fund game, The 1984 spring Olympiad Fund game, and the 1984 International Fund game. The qualifying events for the 1986 Finals will be the 1984 fall OF game, the 1985 spring OF game and the 1985 IF game.) Players who qualify at these events will be eligible for the Unit level game, which will qualify one pair for every 250 unit members for the next level, presumably the National Final. The winners of each Final will be subsidized Canadian pairs to the World pairs Olympiad.

Of particular interest to Vancouver area players, the James D. Denaldson Trophy will be awarded to the winners of the CPC by the CBF.

Ochadian National Teams Championship

The Unit 430 board received a letter from CBF Zone Director Doug Units of BC re the expense of sending teams to the CNTC Zone Final in Edis three representatives in the National Final. Teams from other units rould not be allowed to play in their game.

The board, while expressing sympathy for the travel problems of far-Charles State, white stylessing sympathy to the state project of the British Schunbia Team Championships, and is protesting to Mr. Andrews and to the Charles Situation can only lead to the weakening of our B.C. representation the Canadian Championships. It is a disservice to bridge in BC and to the Championships themselves to send less than our proven best. We sincerely acos that an amendment can be made which will satisfy all parties.

The National Finals will be held June 16-20 in Toronto, and next year on June 15-19, also in Toronto.

The good news is that the Pomberton Bridge Club will be holding a cualifying game on January 15 at 1:30 & 7:30, cost \$40 per team.

The CBF has elected Doug Andrews as Co-Chairperson of their new Public Awareness Committee. The Committee has been formed 'to promote AWareness of the goals of the CBF throughout the country and generate a feeling of identity and unity among Canadian bridge players. Since the issue in question contained a report from our Unit correspondent, Aidan Ballantyne, we thought you might like to see what the folks back East were digesting along with their tarte au sucre. And so, the news as it was:] -Ed.

At the winter sectional the unit presented two of its most important trophies. The Phil Wood, awarded to the highest point-getter at Vancouver sectionals, was won by Mike Dimich for 1982. Mike's performance was all the more outstanding in that he missed the summer sectional in order to play the CNTC Finals in Toronto. Paul Conroy of Seattle earned the Under 200 master point trophy. Each will receive a year of free plays at Vancouver sectionals. The Edith Bonnell Memorial Trophy, awarded to the woman earning the most points at Vancouver sectionals, was won by Jean Groome, disproving the modified adage, "those that can, play; those that can't, administer".

The Unit Mini-McKenney winners were recently announced. . . The closest race was the Advanced Senior Master Category where Dave Waterman nipped Martin O'Reilly by .24 of a point. Dee Steil was third, one point out of first. The Waterman - O'Reilly rivalry dates back to the Seattle Center Regional where Dave achieved LM status just days ahead of Martin. Martin has asked for a recount and was last seen rummaging through his dressing table in search of stray rating point slips. The Advanced Senior Master race had many features in common with the Yarington-Urbaniuk contest for the Kirkwood. The scenario might have unfolded something like this:

The IMP League has almost reached the playoff stage. In the A Division, Dimich leads with 165 (2 matches to play), Bryden has slid into second spot with 152, but has only one match to play. Golden age Masters

The ACBL's Golden Age Master certificate may be awarded to any player who has attained the age of 70 years and has accumulated 300 Master Points of any coloration, or to any who has attained the age of 80 and has at least 100 points.

It should be noted that this is an honourary status in recognition of attained age and master points and is not the equivalent of Life Master, nor does it carry any perquisites such as exemption from ACBL dues or fees.

Each applicant, or person applying on behalf of the player, is asked to furnish the player's name, ACBL player number, and the player's birthdate and current address. Do you know someone who might qualify for this award?
