It was decided (Gray, Don) that there will be no second place winners and trophy winners will receive whatever free plays come with the win.

#### 15. DINO News: Nick

#### 16. IMP Leagues: Eda

There was nothing to report.

#### 17. New Business:

- a) Support for the Regional: Margaret asked the Board to provide some support in terms of a subsidy for the April Regional. The Board discussed offering \$1000 for various things. This was tabled.
- b) Subsidies: Our current policy is that only players who actually play in events can receive a subsidy. It was noted that the CBF pays coaches and non playing captains. After some discussion, it was voted to reaffirm our existing policy. (Larry, Nick) approved

c) Margaret, who is opening a bridge club, asked that she keep the dealer machine at her house. Normally it is stored in the Unit 430 cupboard at the VBC. It was decided to rent the dealer machine at a rate of \$5 per use and the Bridge Mates at a cost of \$1 per Bridge Mate, per use, commencing now. However, it was decided to offer a 3 month waiver to support the new club. These costs were set as a way to refurbish the machine whenever necessary. The machine must be returned to the VBC, in good working condition, in time for all tournaments.
